## Social Media and Email Giveaway Rules

---

### Credit Union 1

By entering this giveaway, the participant agrees to abide by the following terms and conditions. You must have internet access to participate. Void where prohibited.

1. **NO PURCHASE IS NECESSARY TO ENTER OR WIN.**
2. **Sponsor.** CUI Social Media and Email Giveaways are sponsored by Credit Union 1 ("Sponsors"), 1941 Abbott Rd, Anchorage, AK 99507.
3. **Prize.** The number of prizes and description of the prize will be listed on the giveaway social media post or within the email for each giveaway promoted by the Sponsor. Prizes are not negotiable and cannot be exchanged for cash value.
4. **Entry Period.** The entry period for the giveaway will be listed on the giveaway social media post or within the email for each giveaway promoted by the Sponsor.
5. **Eligibility.** Must be a legal Alaska and US resident, 19 years or older. Employees of Credit Union 1, their immediate family members, and those living in the same household are not eligible to participate. Void where prohibited by law.
6. **Odds of Winning.** The odds of winning each prize will be based on the number of eligible entries received.
7. **Winner Selection.** The winner will either be selected by a random generator or as specified in the post or email. If there is a tie, then out of the tied participants, a winner will be randomly selected.
8. **Winner Notification.** The winner will be notified via the social media outlet used to enter, or by the contact information provided through the form submission. Suppose a potential winner does not respond within twenty-four (24) hours of the first notification attempt. In that case, the potential winner will forfeit their prize, and an alternate winner may be randomly selected based on the Sponsors discretion.
9. **Claiming Prize.** Winner(s) must be able to claim the prize by picking it up at Credit Union 1, 1941 Abbott Rd., Anchorage, AK 99507, unless other pick-ups or delivery arrangements are agreed upon by Credit Union 1.
